

Village of Rossville
Police, Health & Safety Committee Meeting
December 15, 2025
6:15 p.m.

A quorum was established as Chairman Wallace and Trustees Mikel and Gammon were physically present at the committee meeting held at the Rossville Municipal Building, located at 120 East Attica Street in Rossville, Illinois. The guests present were Mayor Black, Clerk White and Kenneth Gammon.

Chairman Wallace called the meeting to order at 6:15 p.m. The purpose of the meeting was to review/approve past minutes, review outstanding ordinance violations, the prior month's police actions, monthly ordinance spreadsheet, review maintenance log sheets on police vehicles, property at 214 E. Attica follow up, discuss Flock group amendment, police applicants and class at ILEAS, tuition free (for qualified SROs McFarland, Bostwick and Finley) called Identifying & intercepting school Violence through Leakage on January 12-14, 2025 held daily from 8am-4pm.

Minutes of the November 17, 2025 committee meeting – Minutes of the meeting held on November 17, 2025, were presented. Motion was made by Mikel, seconded by Gammon to dispense with the reading of the minutes and approve the minutes as presented. Vote: Mikel, yes; Gammon, yes; Wallace, yes.

Prior Month's Policing Activity – Trustee Gammon asked if the committee needs to accept Officer McMilleon's resignation since we have in the past. Trustee Wallace asked if a resignation was submitted. Clerk White stated a resignation was submitted. Trustee Gammon asked if the Identifying & intercepting school violence through leakage class is for the SROs? Clerk White stated the class is for SROs for continuing education, which would include Officer Finley since he is a certified SRO.

Trustee Wallace asked if the FLOCK cameras are working at all. Mayor Black said the cameras are working but not correctly. Trustee Gammon asked if the cameras have to be listed on our insurance. Mayor Black stated the City of Hoopeston has their FLOCK cameras on their insurance. Mayor Black sent FLOCK an amendment to the agreement saying it should be their responsibility to fix the cameras if they are hit or damaged. Mayor Black is waiting for a response from FLOCK. Mayor Black suggested if FLOCK says it is not their responsibility to repair the cameras, the Village can add it to its policy. Mayor Black responded to FLOCK saying FLOCK should be responsible. It probably wouldn't cost much to add the cameras to the Village insurance. Mayor Black stated that if FLOCK says NO to his amendment, the Village will add the cameras to the Village insurance to make sure they are covered.

Trustee Gammon asked if the Identifying & Intercepting School Violence through Leakage class is just for SRO's and do we need to approve this class and who will attend. Being not sure if Chief Greene needs the training, a motion was made by Gammon, seconded by Wallace to approve Officers Finley, Bostwick and McFarland attend the class in Urbana on January 12-14th from 8am-4pm. Vote: Gammon, yes; Wallace, yes; Mikel, yes.

Monthly ordinance and maintenance log sheets – Clerk White did not receive a monthly ordinance spreadsheet or maintenance log sheet to attach to the agenda. The Explorer is in the shop at Smitty's.

Old Business – Mayor Black stated he has not received anything new regarding 214 E. Attica.

Motion was made by Gammon, seconded by Mikel that if FLOCK agrees to the amendment, the Village is good; if FLOCK does not agree to the amendment, the cameras will be added to the

Village insurance even though we don't own them. Vote: Mikel, yes; Gammon, yes; Wallace, yes.

Trustee Gammon asked what paragraph Trustee Layden wanted removed. Clerk White was unclear on which paragraph.

Trustee Gammon noticed that Officer Finley is the only officer on the schedule for the last 2 weeks of December. Mayor Black had approved Chief Greene's vacation for the last 2 weeks of December when Officer McMilleon was still employed. An ad was placed for qualified officers. Applications have been received but not from qualified officers.

Motion was made by Mikel, seconded by Wallace to adjourn the meeting. Vote: Gammon, yes; Wallace, yes; Mikel, yes. The meeting was adjourned at 6:35 p.m.
